### **President's Message**

#### **Greening It Up**

As I write this on St. Patrick's Day—a day for the wearin' o' the green—spring and the green it brings are just around the corner. Your executive is a bit greener, too, as we held our most recent executive meeting by teleconference. Usually, we meet face-to-face at the annual conference and then hold one or two other meetings a year in which several of us meet centrally and others call in for part or all of the meeting. The teleconference made us a bit greener, saved money and put all exec members from all regions on an equal footing. The last means that we all had an equal chance for participation; generally, those who call in can rarely hear everything that is said, and it is harder for them to participate fully in discussions and decisions. The teleconference worked well—we all missed the energy generated in a face-to-face meeting, but a teleconference seems to be a workable, less expensive and more equitable alternative, so we expect to try it more often.

One of the things we decided at that meeting was to develop a promotional brochure for ISC. Our publicity coordinator, Mary Newberry, has taken that on with the help of a committee of volunteers. Thanks to all of you who responded to her call on the listsery.

Another ongoing concern that we are dealing with is member communication. Membership coordinator Audrey McClellan has begun a

new process to ensure that e-mails to members are accurately and consistently sent, and she is also looking at a format for annual checks of our broadcasting system.

I have been tasked with a review of our listserv. Given the free providers that now exist (e.g., Yahoo), it is time to take a look at whether we are using the most effective and inexpensive service.

These are just some of the activities at the executive level. More deeds and details can be found in the other executive reports in this *Bulletin*. Ruth Pincoe has been far afield in her role as International Society Coordinator, our regional representatives have been stirring up enthusiasm across our country, enhancements are coming to the *Bulletin*, *Register* and web site, and our finances are in good shape.

My final word is about our forthcoming Annual General Meeting and conference, this June 3 and 4 in Toronto. Coordinator Anna Olivier and her team have been working hard on setting up a great conference for us. Angela Wingfield, venue and catering coordinator, has booked us facilities on the U of T campus. Marie Gabe, program coordinator, has lined up a terrific set of presenters, including Katherine Barber, former editor of the *Canadian Oxford Dictionary*, as our keynote speaker. I hope to see you all there!

It's that time again, and I still have those same three balls in the air that I mentioned last time round: the March issue should be with you by the time you read this, the June issue is moving forward in fits and starts (contributors seem to be having even more difficulty than usual in getting to the point where they have something more than "best endeavours" assurances to offer me, but then being an editor is all about living with risk and uncertainty), the September issue (edited by the China Society) promises well and—fourth ball, I think—I'm starting to put together material for December 2009.

#### **New Web Indexing SIG Manager!**

The Web Indexing Special Interest Group is pleased to announce that its new manager, as of January 2009, will be UK-based indexer Rebecca Linford. Jessica McCurdy Crooks, who was manager since 2007, will step down at the end of this year. Rebecca is a freelance indexer, who won the Web Indexing SIG's inaugural Web Indexing Award in May 2008. It is only fitting that someone such as her will lead the charge of this dynamic Group.

As a part of her new role, Rebecca will be ensuring that the Web Indexing SIG Award continues.

Rebecca's appointment continues to ensure that the Web Indexing SIG maintains its position as one of the most international of the SIGs. #### Legal Indexing SIG

The Legal Indexing SIG was formed in June 2006 and became an officially affiliated SIG in October 2006. The SIG is for indexers who specialize in legal indexing or who are interested in learning more about it. Members' expertise covers a wide range of materials, from statutes, codes, and rules to textbooks, practitioner's treatises, legal newsletters, legal self-help, and many other types of materials.

Mary Harper had the initial idea to form the SIG and serves as moderator and primary webmaster. She asked Maria Sosnowski to join in the endeavor, and Maria became the events coordinator. Susan Barnes stepped up as treasurer. Janyne Ste. Marie and Mary Wendt volunteered to lead the marketing team. Janyne also serves as co-webmaster in charge of the member's directory.

The web site (<a href="www.legalindexing.org">www.legalindexing.org</a>) serves as the centerpiece of the marketing initiative. There is a "Find an Indexer" page where members can list information about themselves for potential clients, a "Submit a Project" page for publishers, and a page for legal resources. There is also information about the need for professional indexers.

The current focus of the marketing initiative is on marketing the SIG to legal publishers. A GoogleAdWords campaign is in progress and a phone-calling campaign is in the works to inform editors about the web directory. Plans for an emailed newsletter are under discussion and there is a PDF brochure for members to use in their marketing.

As an affiliated SIG, the Legal Indexing SIG is open to members of indexing societies worldwide. Dues are \$20 (U.S.) per year, which covers web site and marketing expenses. The members' discussion list is on Yahoo Groups at <a href="http://finance.groups.yahoo.com/group/legalindexingSIG/">http://finance.groups.yahoo.com/group/legalindexingSIG/</a>. The list serves as a forum for casual networking, SIG communications, and peer reviews, and as a place for members to receive assistance on topics related to the indexing of legal materials. The SIG will have its annual meeting at the ASI conference in Portland this year.

#### Saskatchewan Legislature, March 14, 1978

When indexing the responses to the Saskatchewan budget speech in March 1978, it was amusing to read the following transcription from the Honourable E. Kramer, Minister of Highways and Transportation, who was critiquing the opposition Progressive Conservative Party.

Mr. Speaker, I was watching the antics and the movement back and forth—they are a fluid group over there. I have an Indian friend who is a chief of an Indian band. He came to me and said, "Those Conservatives, do you know some of them?" I said, "Yes, not any better than I want to. I know them I see them across the floor." He said, "There are some of those fellows we would like to make chiefs." I said, "Oh, you want to make them chiefs." He said, "I would like a little advice about those fellows. Do you think we are doing right? We had a contest and we have chosen the member, Mr. Lane for Qu'Appelle, and Mr. Thatcher for Thunder Creek and of course the Leader, Mr. Collver and the member for Rosthern, Mr. Katsman, we have to give them Indian names. We have finally come up with the names. The member for Qu'Appelle, we are going to call him Changing Wind and the member for Rosthern we call him Passing Wind. The member for Thunder Creek him Broken Wind. We have used those for the braves. Now for the chiefs, we honour them by calling them Hand, like Yellow Hand and Strong Hand. We got a name for the Leader, Smooth Hand." I said, "Smooth Hand, how come?" He said, "Well in Cree we got no word for slippery."

Today, the Speaker would probably not allow this kind of critique. Certainly, the actual names of members are not allowed: members have to be identified by constituency, title, or position.

#### International Liaison: Ruth Pincoe

#### **International News**

The biggest news on the international front is the 2009 International Triennial Meeting, which was held in Maropeng, South Africa, during the annual conference of the Association of South African Indexers and Bibliographers (ASAIB). The purpose of these meetings, which are held every three years, is to strengthen ties among the various indexing societies and indexing groups or networks around the world, and to review the International Agreement, which covers, among other things, the various privileges that each society extends to members of all other societies. Representatives to this meeting were Marlene Burger (ASAIB), Caroline Diepeveen (Nederlands Indexers Netwerk, also representing the Deutsches Netzwerk der Indexer), Jill Halliday (Society of Indexers [Britain]), Ruth Pincoe (ISC/SCI), John Simkin (Australia and New Zealand Society of Indexers), and Pilar Wyman (American Society of Indexing). Unfortunately, representatives from the China Society of Indexers were not able to make the necessary travel arrangements.

Our formal meeting was very productive, and during the conference we had additional opportunities for informal discussions on a variety of topics. The conference itself was truly international in that all six of the international representatives were assigned one of the conference sessions to chair. The ASAIB conference was magnificent, as was the setting. I will make a detailed report on the International

Triennial Meeting for the ISC/SCI annual general meeting, and will also submit a fuller account of the ASAIB conference to the next issue of the *Bulletin*. The text of the International Agreement will be printed in the upcoming issue of *The Indexer*.

### Training Courses Available for Members of ISC/SCI

There has been some confusion in recent years about the availability of Society-run training courses for members of ISC/SCI, but as far as I can tell, the situation has finally been sorted out. The Society of Indexers (SI) has been running a training course for beginning indexers for quite a while. For members of SI, this course is linked to accreditation. Several years ago the American Society of Indexing (ASI) made arrangements to lease the SI course so that they could offer an Americanized version to ASI members.

These two courses are essentially the same, and both are excellent. The choice is essentially between a training course with a British accent and one with an American accent. The *Register* is done again for another year. Thanks to Cheryl for wading through the primitive text I send her and producing a very professional result on the web site.

This year I asked for executive approval to hand over the electronic file to Cheryl just as soon as it was ready so that the online version could go up while I was still working on the print mailing. That is a time-consuming exercise and I didn't want to hold things up any more than absolutely necessary.

There are 54 people in this year's *Register*, 18 of them from B.C. (or almost 30 percent of the total). I think having the conference in B.C. last year was a factor in that.

Thanks to Ruth who gave me a copy of the Canadian Publishers Directory from Quill & Quire. I

cross-checked the addresses on my publishers list against the *Directory* and updated some of the addresses I had. In doing that, I became aware of many other publishers that might be able to use a copy of the *Register* and I'm considering doing another mailing. (I had a few extra copies printed with that in mind.)

Once again I have to mention Ruth, who told me last December that the theme of the next issue of *The Indexer* would be "indexers available—type publications." I sent Ruth a few notes about our booklet. It will be interesting to see *The Indexer* in March to get a snapshot of how other countries manage their "indexers available." Perhaps we can review our procedures once we know what others are doing and how effective other publications are.

#### **Bulletin** Editor: Natalie Boon

The *Bulletin* is proceeding along fine. We published our last issue and will have another issue coming out in March. I'm low on content for it at this point. As ever, scaring up content is problematic.

I'm working on a draft style guide for the *Bulletin*, which will help maintain a good standard. I'm thinking of asking for input on the style guide, which can be from the executive, or possibly from a few volunteers from the general membership. It likely won't fully be in place for the next issue.

I will be asking for volunteers from the general membership to help with proofreading. We used to have more, but the pool has shrunk as people have gotten busier. Nowadays, often members of the exec who do it, and it's safer to have a wider pool of volunteers. That way, if one person is too busy at that point to do it, then another person can step into the role.

I may be moving production of the *Bulletin* away from Word. Word isn't the best program for layout. It does funky things when you get too graphically heavy. The annual post-conference issue is usually the most affected by that. Because of its faults, making layout changes is far more time consuming and irritating than it should be. You're spending time fighting the program. I currently have access to some other software programs that I'm investigating. When I step down as editor, the next editor would still be able to use Word, and copies of the word template would be retained if I switch production to another program.

### **Regional Reports**

#### Central Canada Representative: Gillian Faulkner

Toronto area indexers continue to meet most months, alternating peer review sessions with specific topics. An Ottawa area group is also meeting regularly. Marie Gabe coordinates these meetings. An overview of each meeting is usually sent out to members, and the sessions are always enjoyable, helpful, and informative. All are welcome to attend.

Position descriptions have been written for each executive post and will soon be available on the website.

#### Prairies and Northern Canada Representative: Viv Cartmell

As this part of the country seems to be a quiet part of the world of indexing, most of this brief report will be about some of the activity in the indexing offices of the Alberta and Saskatchewan legislatures.

One of our members in Alberta who runs his own business and who always responds to my e-mail requests for news writes:

"You caught me on a morning 'between projects' as people used to say, meaning they were unemployed. But things are not that bad. I'm indexing a book from Heartland Associates in Winnipeg that they are sending me a chapter at a time. And I recently did a book on the history of treaty-making between First Nations and European-based governments. There is also something expected from Athabasca University Press.

So things are okay. Can always use more business though, of course."

In Edmonton the Hansard indexer responded to my e-mail request with the following.

"News? Well we just started our second session of the Leg. on Feb. 10. So far the issues have been the economy (and Alberta's looming lack of a surplus, if not an actual deficit), the recently announced oil sands development strategy, and a kerfuffle about the Chief Electoral Officer and his report on problems with the last election.

Everybody is waiting for the Finance Minister's thirdquarter budget update from last fiscal year to see if we are in a deficit position or not. They are also asking when the current budget is going to come out, to see how the government is going to react.

From an indexing point of view, the oil sands and climate change in general are the most involved topics. Climate change especially gets referred to in multiple ways, like carbon dioxide emissions, carbon capture and storage, greenhouse gas emissions, and sometimes even climate change! What's a poor indexer to do?"

In Saskatoon, an independent indexer, Maha Kumaran, has completed a first index: congratulations and may you get many more!

In Regina, the spring portion of the second session of the 26th Legislature begins on March 2, 2009. Provincial budget day is March 18, 2009... hmm, just a day after St Patrick's Day, so it will be interesting to see how many green programs will be announced. As with the rest of Canada, the state of the provincial finances and the economy are bound to be front and centre of the budget.

I'll be busy grinding my way through about fifty-six speeches in the budget debate. Right now I'm working through the budget debate for 1978: another period of recession in Canadian history. One member of the opposition (G.H. Penner) referred to it as the "lipstick and powder" budget because he said it was basically cosmetic in nature. I couldn't resist: "lipstick and powder" appears as a subentry under "Budget."

#### Western Canada Representative: François Trahan

ISC/SCI-BC Vancouver members had their most recent meeting at the Vancouver Public Library on Saturday, January 17, 2009.

There were a dozen of us again, and after short introductions we went through a list of upcoming conferences (ISC, ASI, EAC, etc.) and local associations' events where people can network. Karen Griffiths, who had assembled the list, emphasized the importance of making contacts and letting everyone know about our freelance work.

We then talked about e-books and their effects on indexing, and about indexing of policy and procedures manuals, before doing a peer review of an index done by a team of two indexers. Many questions were raised about the process, the indexing decisions and challenges, and interactions with the authors, the editor, and the publisher.

Our next meeting will be Saturday, April 18, 2009, at the same location. We discussed agenda items and ideas for that day.

March's meeting was a special one as the ISC/SCI members and other interested indexers and librarians took part in a panel discussion at the School of Information Management at Dalhousie University.

We had a great panel which the students of the Indexing and Abstracting class enjoyed and found very enlightening.

**Barbara MacKenzie** - Librarian, teacher at NSCC, freelance business information consultant. She is taking an indexing course and also planning to become an ISC/SCI member soon.

**Penny Logan** - Librarian, in charge of Capital Health Library Services, Halifax.

**Linda Lefler** - New indexer, engineering background, new ISC/SCI member.

**John MacLeod** - Nova Scotia Archives and Record Management archivist/indexer, indexing pictures.

Two ISC/SCI members, Noeline Bridge and Linda Lefler, talked about book indexing, courses available for indexers, ISC/SCI as a professional group and the advantages it offers to its members, and how to start an indexing business. Noeline, being a very experienced indexer, and Linda, just starting her business as a new indexer, made an excellent combination given their perspectives.

Altogether, this was a great monthly meeting for the indexers, librarians, and students who are about to take their place in the professional world.

### **Book Review**



From Flock Beds to Professionalism, a history of indexers By Hazel K. Bell (New Castle, Delaware: Oak Knoll Press, 2008. 333 pp., also published by HKB Press, UK)

I was delighted to receive a copy of this book. I'd heard it was to be published. The *Bulletin* published some information on it in the Summer 2008 issue (Vol. 30, No. 3, pg. 34).

The first part of the book is biographical, giving short biographies of sixty-five indexers from the Renaissance to the present day. Some of the names weren't a surprise—indexing notables including Henry B. Wheatley, Hans Wellisch and Nancy Mulvany—others were a complete surprise.

I had no idea that Lewis Carroll, Friedrich William Nietzsche, and Georgette Heyer had been indexers! The more I read, the more I wanted to read. Of Nietzshe, Bell writes,

In the first section, the biographical focus is on the indexing lives of the subjects. How they indexed is also discussed, within the context of their lives.

The gradual change in techniques was interesting. It became evident that as in many other technologies, the rate of change had radically increased in the modern period.

In the biographical coverage, we are treated to insights into the way that indexers have thought for centuries. In my opinion, that way

of thinking will remain crucial, though the format may evolve.

The second half of the book deals with the growth of indexing societies. The problems that the early societies faced is described in loving detail. I found the history of the development of SI's indexing awards particularly interesting.

I was pleasantly surprised to find that the early history of our own ISC/SCI was included. If you're looking in the index, it's under "Indexing and Abstracting Society of Canada."

The index itself is lovely, using many subtleties that I rarely see in practice. Distinctions are made between entries dealing with the main entry of a subject, works by a subject, where a subject is cited, and illustrations. I must admit that seeing that level of detail in an index is wonderful.

There's an extensive reference list, as well as a chronology of print-only indexing.

The book ends its coverage in 1996. In the closing paragraphs Bell discusses the rise of the Internet, and the probable negative effects of computers on print indexing.

As a newer indexer who came to the craft during this "post-print indexing" period, I'd like to see a book that deals with indexing through the modern period. (I realize that's beyond the scope of this book, and not a criticism of it at all.)

I have to strongly recommend this book for anyone wanting to immerse themselves in the history of our shared profession.
